Course Textbook: The instructor will write lecture notes for the course (in lieu of an official textbook) as the semester progresses. The course will roughly follow the presentation from “Linear Algebra” (4th or 5th edition) by Friedberg, Insel, and Spence, but it is not necessary to purchase the textbook for this course.

Prerequisites: Math 1365 (Introduction to Mathematical Reasoning) or an equivalent familiarity with proof, and either Math 2331 (Linear Algebra) or Math 2341 (Differential Equations and Linear Algebra) or an equivalent familiarity with matrices.

Course Philosophy: Math 4571 is a second course in linear algebra that covers the material from a theoretical perspective. Linear algebra is a fundamental stepping stone to almost every area of advanced mathematics (especially abstract algebra, functional analysis, algebraic topology, differential geometry, and applied and computational mathematics) and the sciences (especially scientific computation, theoretical physics, complex systems analysis, and applied engineering) and is one of the most fundamental mathematical tools in existence, rivaled only by calculus.

The primary theme of Math 4571 is to study vector spaces and linear transformations from a rigorous, formal standpoint. Many applications of linear algebra can be treated entirely from a computational perspective (e.g., in introductory linear algebra courses like Math 2331), but this approach often leads to treating theoretical constructions like a “black box”. The goal of Math 4571 is to gain a deep understanding of how linear algebra works conceptually, in addition to understanding computational applications, in a way that provides a steady foundation for future study in mathematics and the sciences.

At the end of the course, you will have a solid grasp of the fundamentals of vector spaces, linear transformations, inner products, and quadratic forms, and how they can be used in a wide variety of applications. Success in this course thereby demands facility with the basic concepts, with the underlying theory, and with its applications.

Grades and Exams: Your course grade consists of **40% homework**, **25% midterm**, and **35% final exam**.

The homework score consists of the average of the written assignment scores, with the lowest score dropped.

There will be two takehome exams (a midterm and a final). The midterm is tentatively scheduled to be due on Thursday, March 10th, and the final exam is scheduled to be due during the final exam week.

An overall raw score of 92% will be **at least** an A, 90% will be **at least** an A-, 88% will be **at least** a B+, 82% will be **at least** a B, 80% will be **at least** a B-, 78% will be **at least** a C+, 72% will be **at least** a C, and 70% will be **at least** a C-.

If you feel that an assignment or exam has been misgraded, please talk to the instructor directly. Requests for regrading will not be considered more than two days past the date the assignment or exam was returned.

Homework Assignments: Written assignments will be assigned weekly and due via Canvas by 11pm Eastern, typically on Tuesdays.

It is highly recommended to start the assignments early: many problems will require substantial thought and effort to solve, even if the solution is ultimately fairly short. Do not fall into the trap of only starting the assignment the evening before it is due!

The lowest assignment grade is dropped, to provide you a cushion if an emergency arises and you cannot complete an assignment. For logistical reasons, extensions cannot be granted under any circumstances.

Written assignments should be organized carefully, neatly, and in complete sentences, with concise well-reasoned logical arguments. Cite any external resources used, and clearly label all problems. If you collaborated with any other students, write the names of all collaborators on the top of your assignment. If your assignment is more than one page long, use a staple or paperclip to affix the pages together. **Failure to adhere to any of these guidelines may result in point deductions, at the grader's discretion.**

Course Schedule: The course and lecture notes are tentatively organized into six chapters, as follows:

Week 1: Chapter 0 ~ Preliminaries: Vectors, matrices, determinants, fields, polynomials, induction

Weeks 2-3: Chapter 1 ~ Vector Spaces: Definition, subspaces, span, linear independence, bases and dimension

Weeks 4-6: Chapter 2 ~ Linear Transformations: Kernel and image, the nullity-rank theorem, algebraic properties, matrices associated to linear transformations, isomorphisms and inverses, change of basis and similarity

Weeks 6-8: Chapter 3 ~ Inner Products: Inner products, norms, orthogonality, the Gram-Schmidt procedure, orthogonal complements, linear functionals, adjoint transformations, least-squares approximation, Fourier series

Week 8: Midterm exam due, covers chapters 1-3.

Weeks 9-11: Chapter 4 ~ Eigenvalues, Diagonalization, and the Jordan Canonical Form: Eigenvalues, eigenvectors, the characteristic polynomial, the Cayley-Hamilton theorem, diagonalization, Markov chains, generalized eigenvectors, the Jordan canonical form and its applications, Hermitian operators and the spectral theorem

Weeks 11-14: Chapter 5 ~ Bilinear and Quadratic Forms: Bilinear forms, diagonalization, quadratic forms, the second derivatives test, Sylvester's law of inertia, applications of quadratic forms, singular value decomposition, pseudoinverses.

Week 15: Final exam due, covers chapters 1-5.

Collaboration Policy: Mathematics is fundamentally a collaborative endeavor, and discussing the course material with others is an excellent way to solidify your own understanding. However, it is critical not to outsource your learning! You cannot expect to retain knowledge if you do not solve your homework problems yourself, whether because you relied on other people to explain to you how to do the problems, or because you relied too heavily on technological assistance.

On written assignments, you may work together with other people, **but you must write up your work independently**. If you use **any** external resources (e.g., wikipedia, stackexchange, other books beyond the course text or notes, other people, etc.) you must say **what results you are citing and where they are from**. If you happen to find a solution to an assigned problem online or elsewhere, it is academically dishonest to copy the solution and present it as your own work.

Please also note that 60% of your course grade is determined by the exams, on which collaboration is not allowed.

Attendance Policy: It is expected that you will attend every class. This course moves very fast, and it is quite possible to fall behind even if you only miss one day. If you miss class for any reason, it is highly advisable to consult the course lecture notes to catch up, and you may also wish to obtain notes from another student. It is your responsibility to be aware of all information announced in class, including modifications to the course syllabus or schedule, even if you are absent.

If you will be absent from a class activity due to a religious observance or practice, or for participation in a university-sanctioned event (e.g., university athletics), it is your responsibility to inform the instructor during the first week of class and provide appropriate documentation if required. Your instructor will work with you on alternative and reasonable arrangements for any time missed.
